Scott and Carol met at UMD, where they were both accounting majors. They got married in 1986. Scott has a bachelor's degree in accounting from UMD and a master's in business administration from the University of St. Thomas. After college he spent three years with a CPA firm in Duluth.

### MAKING A DIFFERENCE IN OUR COMMUNITY

Scott is a member of the Eagan Rotary Club and has served as President twice. He says Rotary is a great organization that is about making a difference in our community. "The Eagan Rotary Club has donated hundreds of thousands of dollars to meaningful community organizations in the form of grants that supported operations and projects," said Scott. "We have also supported a number of Capital projects in Eagan. These include funding the Eagan Rotary Bandshell, purchasing and installing park equipment at Blackhawk Park, funding the Eagan Fire Department Safety Trailer and most recently committing \$150,000 to help start Art Works Eagan."

"Years ago, a group of Rotarians began exploring the idea of building a bandshell as a gift to Eagan as a place where the community could enjoy music," said Scott. "When the community center plan was announced, it was a natural partnership. The vision of those Rotarians made this happen. My role was focusing on ways to build the fundraising at our annual gala. I was involved with sponsorships."

Scott has also served as the Chair of the Dakota County Regional Chamber and was a 9-year board member. "The Chamber is an advocate and connector of the businesses in Eagan and Dakota County. This has been very meaningful to me and the banks I have worked for" said Scott. "The opportunity to work, learn and visit with other business owners has been a key to my career success."

#### SAVING A GREAT COMMUNITY TRADITION

Several community members, along with a new board of directors deserve credit for continuing Eagan's Funfest, which attracts about 100,000 people every year. About three years ago after 50 years of celebrations, it was decided to discontinue it. "I was one of several community members who met with the City leadership to discuss the idea of continuing the event. We considered options including different dates and possibilities. In the end, we agreed to continue the event." said Scott. "I agreed to be the chair of a new board to keep this great Eagan community tradition going."

## **CELEBRATING 150 YEARS OF EAGAN**

Of everything hé has done in the community, Scott says chairing Eagan's Sesquicentennial in 2010 has was one of the highlights.. "Over the course of the year, businesses, schools and churches helped us raise funds and awareness for the two food shelves serving Eagan. Initially our goal was to raise 150,000 pounds of food for Eagan's 150 years. We hit that goal early in the year. We decided to raise another 150,000 pounds for the next 150 years of Eagan," said Scott "When it was all said and done, we raised nearly 400,000 pounds of food. So many great people jumped in and helped. What great fun memories!"
